

## SECTORAL ECONOMIC STRUCTURE IN THE CONTECST OF SOCIAL-ECONOMIC DEVELOPMENT OF SOCIETY STAGES

**Research methodology.** The results are obtained through the use of a systematic approach – while determining the elements of the economic system structure; structural and functional analysis – while defining the «whole» model and the «functioning» model in the sectoral structure; the methods of dialectics – while studying the sectoral structure of national economy on the basis of the «horizontal» and «vertical» characteristics development.

**Results.** The methodological principles of the sectoral economy structure analyses and its relationship with the stages of economic development are considered. While structuring the economic systems, it is proposed to combine the quantitative and qualitative characteristics of the economy systems, and in addition, take into account the peculiarities of national development that can be nonlinear, inverted and bifurcated. It is emphasized that each sector has not only its life cycle, but is also a full-fledged viable element of the economy as a whole and, therefore, contains the economic and social components. On the bases of the «whole» and «operation» models it is proved that the civilizational development of the society is a process of quantitative and qualitative progressive changes within each of the economy sectors.

**Novelty.** The theoretical and methodological approach to the study of the national economy sectoral structure is grounded on the basis of the «horizontal development», «vertical development», «whole model», «operating model» categories. It is offered to point out the growth poles in each sector that provide the sector's own economic development, on the one hand, and the national economy development as a whole, on the other hand.

**Practical value.** Scientific principles that were introduced can be used in development and improvement of the legislative acts that provide the enforcement of the national and regional structural policy.
